**PRESS RELEASE**

As part of the share buy-back program authorized by the Shareholders' meeting of 22 April 2014, it is noted that ASTM S.p.A. acquired, in the period from 11 November to 13 November 2014 included, n. 17,401 of the Company's ordinary shares (equal to 0.02% of the share capital), at an average price of € 9.3567 per share for a total amount of about €162.8 thousands.

The daily detail of the operations is reported below:

Since the start of the share buy-back, ASTM, S.p.A. acquired a total of n. 422,590 own shares (corresponding to 0.48% of the share capital) for a total amount of € 4.481 millions.

As a result of the above mentioned acquisitions, ASTM S.p.A. currently holds n. 4,076,443 own shares (4.63% of the share capital) of which n. 4,054,943 shares directly owned and n. 21,500 shares indirectly through the controlled company ATIVA S.p.A..
